



## Notice of closure of Branch of HSBC Bank (RR) (Limited Liability Company) in Saint-Petersburg

Dear Clients,

We would like to inform you that in order to simplify our banking structure in Russia we, HSBC Bank (RR) (Limited Liability Company), located at 2 Bld.2 Paveletskaya Square, Moscow 115054, General Banking Licence No.3290 (the Bank), intend to close our Saint-Petersburg Branch, located at: Liter A, 1/36 Volynsky Lane, Saint-Petersburg, 191186, Russia (the Branch).

The Branch will be closed on 31 March 2021.

This planned change will not have any material impact on your business activities with the Bank. We will continue to provide you with the full range of banking services after you move your accounts and balances from the Branch to the Bank's principal office.

Additionally, the Bank will open a Representative office in Saint-Petersburg to support our clients from the North-Western Federal District. We will handle all arrangements, with minimal efforts required from your side. Thanks to the well-tested functionalities provided by our own systems and payment system of the Bank of Russia, your payments will continue to be serviced smoothly under the new structure.

Herewith the Bank assures you that it will meet all its obligations towards creditors and clients who have accounts in the Branch, whether your accounts and account balances will be moved to the Bank or to other banks in the Russian Federation.

Account balances that after closure of the Branch are not transferred to your accounts with the Bank or other Russian banks will be credited to the Bank's main correspondent account with the Bank of Russia:
